All new Trailblazer Firearms, LLC firearms are warranted to the original retail purchaser only for the lifetime of the said original retail purchaser.

### **What Will We Do?**

Trailblazer Firearms, LLC will, at its option, repair or replace without charge any Trailblazer Firearms, LLC firearm that fails due to a defect in materials or workmanship. Parts and labor are included. Repairs are warranted for the duration of the warranty. If Trailblazer Firearms, LLC replaces a firearm under this warranty; you will receive a new warranty.

### **How to Obtain Service:**

Contact Trailblazer Firearms, LLC for a Return Authorization Number before sending your firearm freight prepaid to Trailblazer Firearms, LLC at the address listed below. No C.O.D. shipments will be accepted. Only the existing Trailblazer Firearms, LLC Service Center or any other authorized Trailblazer Firearms, LLC Service Center that may be established by Trailblazer Firearms, LLC shall be authorized to make warranty repairs. Return the complete, unloaded firearm with a detailed description of the problem. (DO NOT send any live ammunition with the firearm. If you must send ammunition to us for proof purposes, be sure that it is sent separately from the firearm.) You must provide Trailblazer Firearms, LLC with satisfactory proof of date of original purchase. We strongly recommend that you return a properly completed warranty registration card or an acknowledgment of online warranty registration to establish eligibility for warranty service. If you do not return a warranty card or an acknowledgment of online warranty registration to Trailblazer Firearms, LLC, you are required at the time you send your firearm to Trailblazer Firearms, LLC warranty service to provide proof of the date that you purchased your new Trailblazer Firearms, LLC firearm. ANY UNAUTHORIZED ALTERATION OR MODIFICATION OF THE FIREARM OR USE OF PARTS OR COMPONENTS NOT ORIGINALLY MADE BY TRAILBLAZER FIREARMS, LLC SHALL VOID THIS WARRANTY. TRAILBLAZER FIREARMS, LLC SHALL NOT BE RESPONSIBLE FOR ANY CLAIMS INVOLVING THIS FIREARM THAT RESULT FROM THE USE OF FAULTY, NONSTANDARD, REMANUFACTURED, OR RELOADED AMMUNITION OR AMMUNITION NOT MANUFACTURED TO NATO AND/OR SAAMI SPECIFICATIONS.

Under no circumstances shall Trailblazer Firearms, LLC be responsible or liable for incidental or consequential damages with respect to loss of use, loss of business or profits, other economic loss or injury to property, whether as a result of breach of express or implied warranty, negligence or otherwise.
